## PURPOSE



The EJAY Subcommittee is to assist in identifying where racially disparate treatment occurs in the state's juvenile justice system by using reliable data; educating stakeholders on the impacts of racial and ethnic disparities; and promoting and supporting efforts aimed at eliminating bias that can result in the differential treatment of juveniles involved with the system.
